

September 6, 2016 @ 7:00pm**Regular Meeting**

Chairman Dave Anderson called the September meeting to order. Supervisors present Dave Hauser, Jim Roach and clerk A. Anderson. All present stood for the pledge of allegiance.

D. Anderson stated the purpose for recessing the Annual Meeting then turned it over to Moderator Terry Havir. With the Annual Meeting reconvened Havir asked for a motion to adjourn the Annual Township Meeting. Motion was made by Ray Holm to adjourn, seconded by Michael Blassey. All in were in favor. Motion carried.

August minutes were reviewed by all. J. Roach made a motion to accept the August minutes as written, D. Hauser seconded. All were in favor.

Sheila Carlton with Crow Wing County Soil and Water discussed water quality and private forest management options the county offers. Carlton had brochures regarding these plans. There are plat books available at CWCS for \$37.76.

Crosslake Officer Bobbie Willard reported on 47 calls for August.

Assistant Fire Chief J. Roach reported on 7 calls. 2 calls in Center Township, 4 in Mission and 1 cancelled in route.

Fire Relief – J. Roach stated there is an Open House scheduled for September 18th.

Recycle – There were questions regarding the placement of the bins. It was thought that with the added pad, bins would be in a row and not still 3 deep.

Road & Bridge – D. Anderson stated that Mission Way and Mission Cutoff have been completed by Anderson Bros.; crack sealing should begin within the next couple of weeks.

Park & Recreation – Michael Blassey reported that the tennis program has ended for the season. They had about 20 players. The water at the park will be turned off the 1st week of Oct., along with the disc golf being taken down for the season.

Website/Comp. Plan – Terry Havir nothing to report.

Cemetery – Donnie Berg has started the work at the entrance of the cemetery.

Transfer Station – There was no report.

Old Business – D. Hauser asked about the tanker truck at Center Township. He questioned if we could sell them. J. Roach will place a 'for sale' add for them.

New Business – D. Hauser suggested installing an air conditioning unit in the Hall. The unit he checked into was 36,000 BTU it would be \$4,600 installed. D. Anderson made a

motion to have Crosslake Sheet Metal install the A/C unit, D. Hauser seconded. All were in favor.

Treasurer's reports as prepared by Henderson – Receipts were \$6,061.00; Disbursements were \$32,089.18. Balance as of August 20th was \$705,424.83.

August claims were reviewed by all. D. Anderson made a motion to pay claims 7920 – 7943 in the amount of \$44,839.12. D. Hauser seconded and all were in favor.

J. Roach made a motion to adjourn the September meeting, D. Anderson seconded. Motion carried.
